# **City Council Meeting Minutes**

The City Council of Lake View met in a regularly scheduled council meeting on Thursday, January 26, 2023, in the City Hall located at 22757 Central Park Drive, Lake View, AL 35111.

#### **CALL TO ORDER AND ROLL CALL:**

The meeting was called to order by Mayor Adrain Dudley at 6:03 pm. Those present were:

**Motion:** Motion made by Mayor Dudley to appoint Ms. Rosalyn Dudley as temporary City Clerk. Motion was seconded by Councilmember Rolen. Unanimous approval of the motion.

#### **OLD OR UNFINISHED BUSINESS:**

**DotEdison Marketing:** Council members discussed the potential DotEdison contract. Mr. Douglas from DotEdison Marketing was asked to answer questions from the council.

There were remaining questions that councilmembers. A small committee was identified to have further discussion prior to the February work session. This topic was table until the February work session.

**Social Media Policy:** There was brief discussion on the proposed change to the Social Media Policy and the portion to change was read by Mayor Dudley.

Motion made by Mayor Dudley to adopt the 2023 Social Media Policy for the City of Lake View. Motion seconded by Councilmember Ivey. Unanimous approval of the motion.

**GUSC Director:** Ms. Penn, GUSC Chairperson, came forward to discuss the need for a new GUSC Director. Mayor Dudley passed the gavel to Mayor Pro Tempore Kelly Rolen.

Mayor Pro Tempore Rolen made a motion to appoint Ms. Rosalyn Dudley as a Director of the GUSC Board to replace Stephanie Reese by the adoption of Resolution 0101242023. Motion was seconded by councilmember Beaulieu.

Councilmember Beaulieu: yes Councilmember Hudson: yes Councilmember Celmer: yes Councilmember Ivey: yes Councilmember Rolen: yes Mayor Dudley: abstain. Motion approved.

**Lake View Day:** Mayor Dudley discussed the reasons for moving Lake View Day to the spring. The proposed days are 18 and 25 March. It was proposed by Councilmember Beaulieu that the 25<sup>th</sup> be used. This will be used as a planning day going forward.

Alcohol License for the Lake View Club, LLC: Mayor Dudley discussed that the Alabama ABC Board requires approval of the Governing Body of the municipality. This is why this was brought before the council. Motion was made by Mayor Dudley to approve the Alcohol License for the Lake View Club, LLC. Motion seconded by Councilmember Ivey. Unanimous approval of the motion.

**ComPsych Report**: There was brief discussion of the past year's usage numbers for the EAP provider for the Lake View city employees.

Resolution 0101192023 Amending Resolution 1503242022 Construction of Tornado Shelter: Motion made by Mayor Dudley to take up the Resolution for immediate consideration. Motion seconded by Councilmember Ivey. Unanimous approval of the motion.

Mayor Dudley discussed that the amendment is needed because the match the city had was 25% and has not been changed to 10%. Motion made by Councilmember Rolen to accept the Resolution. Motion seconded by Mayor Dudley. Unanimous approval of the motion.

Water Issues: Mayor Dudley discussed the grant applications that were submitted by the city and Warrior River Water regarding replacing old water pipes in the Million Dollar Lakes area of Lake View. Warrior River now has a project number from ADEM for this water pipe replacement project.

**Budget & Finance Committee:** Mayor Dudley stated that the annual audit process is complete, and we are now waiting for the final report from Mr. Wallace. Budget and Finance Committee meetings for the FY2024 Budget will pick up after that is completed.

Mayor Dudley further outlined the issues with the city of Lake View being listed as one word. There was other discussion on what citizens need to do to have Lake View listed as opposed to McCalla, for utilities and other business.

Board of Adjustments: Councilmember Hudson stated that there are no new updates.

**Planning & Zoning:** Mr. Rolen identified that new officers were elected for Planning and Zoning and he is now the Chair for this Commission. He further identified that the Comprehensive Plan has been signed for 2023.

**GUSC:** Ms. Penn identified that the February 2<sup>nd</sup> meeting has been canceled and the next meeting will be March 2<sup>nd</sup>. There was new leadership elected as Ms. Penn is now the Chair for the Lake View GUSC.







This Declaration and Opinion shall not constitute a waiver of the attorney-client privilege.
